#### **Terms of Reference**

---

- a) To steer and have stewardship of agreed definitions and continuous development of Scholarship at Sussex.
- b) To continuously reflect on the ways in which Scholarship can be evidenced, resourced and evaluated.
- c) To have strategic oversight of events, training, resources, and incentives to support scholarship.

- d) To support the development and embedding of Scholarship activities across faculties.
- e) To support the development of staff training, induction and promotion, and to advise on career pathways and promotions processes.
- f) To develop, implement and review communications plans for Scholarship, including a home site, and the promotion, communication and distribution of scholarship outputs, events and resources.
- g) To promote and exchange best practice within Sussex and within the broader HE Sector, in order to enhance Scholarship as a key feature of the culture of the University and support the development of capabilities that enable Scholarship to flourish.
- h) To undertake regular reviews of institutional Scholarship drivers, considering performance against relevant benchmarking data, including the University strategy and key sector actors and regulators and to recommend any updates to UEC, and Senate.
- i) To liaise with Senior stakeholders in Research and Knowledge exchange to review connections and overlap with Research, KEF and CPD dimensions of Scholarship.
- j) To liaise with the Academic Promotions Steering Group to ensure a joined up, collaborative approach.
